HEAD START ROUND UP: 3 YEAR OLDS

2021-2022 GUIDELINES:

- Must be three (3) years old on or before September 30, 2021
- Child's Certified Birth Certificate
- Child's Social Security Card
- Child's Up-to-Date Immunization Record
- **Proof of Income** (2020 Income Tax Form 1040, SSI Income, Unemployment Benefits, TANF, Child Support)
- Court Orders or Legal Documentation of Guardianship
- Calcasieu students with disabilities are eligible for services
- Must adhere to Attendance Guidelines

Eligibility criteria apply providing guidelines are met.

By law, Calcasieu Parish School Board Head Start must provide services to families with a family income at or below the Federal poverty guidelines.

PRE-K ROUND UP: 4 YEAR OLDS

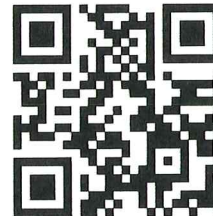
2021-2022 GUIDELINES:

- Must be four (4) years old on or before September 30, 2021
- Child's Certified Birth Certificate
- Child's Social Security Card
- Child's Up-to-Date Immunization Record
- Family's income must be 200% below the federal poverty guidelines
- Must provide verification of income (two (2) consecutive check stubs for each parent or caregiver in the household, SNAP or SSI documentation with child's name, foster care agreement)
- Court Orders or Legal Documentation of Guardianship
- Must provide proof of address (i.e. current electricity statement)
- Must adhere to the Attendance Guidelines
- **Out of Zone Permits are NOT required.** Priority is given to students who live within the school's attendance zone
- Refer to the CPSB website for specific guidelines regarding transportation information and Before and After School Enrichment.
