WHEREAS, Mr. Ron Hayes was elected to a four (4) year term on the Calcasieu Parish School Board representing School Board Election District Five (5) of Calcasieu Parish, Louisiana, and took office in January 2019; and

WHEREAS, Mr. Hayes by letter dated December 30, 2019, resigned effective at the end of the day January 12, 2020, from his position as School Board Member, Election District Five (5), thereby creating a vacancy in the Election District Five (5) seat of the Calcasieu Parish School Board; and

WHEREAS, more than twelve (12) months remain on the term of office of the School Board Member for Election District Five (5) of the Calcasieu Parish School Board; and

WHEREAS, under Louisiana law, it is the duty of the Calcasieu Parish School Board to timely fill this vacancy for the interim period until an election can be held and a new School Board Member takes office in accordance with law.

NOW, THEREFORE, BE IT RESOLVED BY THE CALCASIEU PARISH SCHOOL BOARD convened in regular session on the 14th day of January 2020, that it does hereby appoint Mark Young, effective as of this date, as a member of the Calcasieu Parish School Board representing Election District Five (5) of Calcasieu Parish, Louisiana, with said appointment to expire at such time as the vacancy is filled by an election and taking office by a Board Member in accordance with law.

Upon a motion made by Mack Dellafosse, seconded by Damon Hardesty, and carried, the following proclamation was issued in accordance with La. R.S. 18:602E(2)(a) ordering a special election to fill the vacancy in the Election District Five (5) seat, the vote thereon being as follows:

PROCLAMATION

BE IT PROCLAIMED by the Parish School Board of Calcasieu Parish, Louisiana, convened in regular session on the 14th day of January 2020, in accordance with La. R.S. 18:467, 468, and La. R.S. 18:602, that:

SECTION 1. By letter dated December 30, 2019, Ron Hayes, the duly elected School Board Member representing Election District Five (5) of Calcasieu Parish, Louisiana resigned effective at the end of the day January 12, 2020, thereby creating a vacancy in the Election District Five (5) seat of the Calcasieu Parish School Board.

SECTION 2. On January 14, 2020, in regular session, the members of the Calcasieu Parish School Board appointed Mark Young to replace Mr. Hayes as the School Board Member for Election District Five (5) of the Parish of Calcasieu, Louisiana, until such time as an election is held to fill the seat and the vacancy is filled by the elected member taking office in accordance with law.
