RESOLUTION

A RESOLUTION PROMULGATING THE RESULTS OF A SPECIAL BOND ELECTION HELD IN SCHOOL DISTRICT NO. 27 OF CALCASIEU PARISH, LOUISIANA ON DECEMBER 6, 2014.

WHEREAS, on December 6, 2014, an election was held in School District No. 27 of Calcasieu Parish, Louisiana, to determine the proposition hereinafter set out;

WHEREAS, the returns of said election were canvassed by the Board according to law and notice duly given as provided by law, and the result of said election was declared to be against the Bond Proposition;

NOW, THEREFORE, BE IT RESOLVED by the Parish School Board, governing authority of School District No. 27 of Calcasieu Parish, Louisiana, as follows:

SECTION 1. An election was held in School District No. 27 of Calcasieu Parish, Louisiana, on December 6, 2014, to determine the proposition hereinafter set out; that said election was duly and properly called by the Board by a resolution adopted on August 5, 2014, and recorded in the records of said Board, that notice of said election embracing all matters required by law to be contained therein was given by publication in the Lake Charles American Press, a newspaper published in Lake Charles, Louisiana, and of general circulation in Calcasieu Parish, Louisiana, on September 24, October 1, October 8, and October 15, 2014, the first of said publications being not less than 45 days nor more than 90 days prior to the date set for said election; that this Board did in said resolution designate the polling places for said election and did provide for the use of voting machines in the conduct of said election; that election officials were duly selected; that each election official received the certificate of instruction of the use of the voting machines and his duties in connection therewith as required by law; that the State Custodian of Voting Machines and the Clerk of Court and Ex-Officio Parish Custodian of Voting Machines of Calcasieu Parish made available on the day of the election at the polling places designated for the conduct of said election the necessary voting machines and all necessary equipment and paraphernalia required by law in connection with the use of voting machines at elections; that the Registrar of Voters and the Clerk of Court of Calcasieu Parish furnished to the election Commissioners and Commissioners-in-Charge copies of the precinct registers for each precinct or ward entitled to vote at such polling places; that the Louisiana Secretary of State prepared and certified the ballot used in the voting machines as required by law; that the proposition voted on in said election and as it appeared in said voting machine was in due form provided by law and the resolution adopted by this Board on August 5, 2014, calling said special election; that the results of said election were written on a large sheet of paper at said polling places, which sheet of paper was signed by each of the election officials designated to conduct such election at said polling places and which sheet was thereupon posted in public view at the polling places in accordance with law; that only qualified electors under the Constitution and laws of the State of Louisiana voted at said election; that the officials who served at said election were duly and properly appointed; that the places of all absent election officials were properly filled in accordance with law; that before opening the polls all election officials were properly sworn in accordance with law; that the polls at the voting places were opened at 7:00 a.m. and remained open and until not later than 8:00 p.m.; that after the closing of the polls the votes for and against the proposition were properly counted and tallied and the necessary tabulation blanks, certificates and statements were made by the election officials in accordance with law and the voting machines delivered to the Clerk of Court and Ex-Officio Custodian of Voting Machines in and for Calcasieu Parish, Louisiana, and a copy of the results of said election delivered to the Clerk of the District Court of Calcasieu Parish as required by Louisiana Revised Statutes 18:571; that on December 9, 2014, that being the third day after said election Clerk Court and Ex -Officio Custodian of Voting Machines, after breaking the seals and opening the voting machines used in said election did transcript the totals for the proposition voted upon at said election; and that all things whatsoever required by law to be done in connection with the holding of said election were properly and duly performed in manner and form as required by Part IV of Chapter 4 of Subtitle II of Title 39 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 39:701, et seq.), and the general election laws of the State of Louisiana.

<u>SECTION 2.</u> In said election the following proposition was defeated by a majority of the electors qualified to vote and voting in said election in School District No. 27 of Calcasieu Parish, Louisiana:

BOND PROPOSITION

Shall School District No. 27 of Calcasieu Parish, Louisiana (the "District") incur debt and issue bonds in an amount not exceeding \$12,700,000 for a period not to exceed twenty (20) years from the date thereof, with interest at a rate not exceeding eight (8%) percent per annum, said bonds authorized for the purpose of acquiring and/or improving lands for building sites and playgrounds, purchasing, erecting, enlarging and/or improving school buildings and other school related facilities within and for the District, title to which shall be in the public, which bonds shall be retired with, paid from and secured by ad valorem taxes on all taxable property within the limits of the District sufficient in rate and amount to pay said bonds in principal and interest, with the estimated millage rate to be 20.07 mills in the first year of issue?

SECTION 3. The results of said election shall be promulgated by publication of this resolution of promulgation one time in the *Lake Charles American Press*, a newspaper published in Lake Charles, Louisiana, the official journal of the Board and of general circulation in School District No. 27 of Calcasieu Parish, Louisiana.

STATE OF LOUISIANA : COOPERATIVE ENDEAVOR AGREEMENT PARISH OF CALCASIEU

BE IT KNOWN, that before the undersigned Notaries Public, duly commissioned and qualified in and for their respective localities as bereinafter stated, on the dates hereinafter set forth, and in the presence of the competent witnesses hereinafter named and undersigned:

PERSONALLY CAME AND APPEARED:

CALCASIEU PARISH SCHOOL BOARD (the "School Board"), the governing authority of the Parish of Calcasteu for public school purposes and a political subdivision of the State of Louisiana within the meaning of Article 6, Section 44 of the 1974 Louisiana Constitution, becein represented by its Superintendent, Karl Bruchhaus, duly authorized; and

CALCASIEU PARISH SHERIFF'S OFFICE (the "Sheriff's Office"), the chief law enforcement agency for the Parish of Calcasieu, herein represented by Sheriff Tony Mancuso, duly authorized,

Section 1. AUTHORITY

This Agreement is entered into by the parties under the authority of the Constitution and laws of the State of Louisiana, including specifically Article 7, Section 14 of the 194 Louisiana Constitution.

The Sheriff's Office and the School Board hereby find and declare that they are each authorized by general and special laws to perform the activities berein contemplated and to exercise all powers that may be necessary for completion of the undertaking berein described.

Section 2. PUBLIC PURPOSE

In order to provide a safe and secure learning environment the Sheriff's Office and the School Board do hereby contract for the placement of a fully commissioned deputy sheriff (School Resource Officer) at certain public schools in Calcasiew Parish. It is the express intent of this Agreement that the assigned School Resource Officer shall at all times be under the direct supervision and council of the Calcasiew Parish Sheriff's Office. Additionally, it is the express intent of the paries that the School Resource Officer is to be present on the grounds of the school for the purpose, in addition to his normal law enforcement obligations, of assisting the administration of the school(s) with law enforcement and security related problems. The School Resource Officer's primary duty shall be to enforce the law and to attempt to prevent criminal violations.

Section 3. JOINT EFFORT

The Sheriff's Office and the School Board agree to cooperate in the implementation and administration of the Safe School Program. It is a cooperative effort intended to provide a safe and secure learning environment that is compliant with school board policies and to ensure that school grounds are a safe haven for students. The School Resource Officer's primary duty shall be to enforce the law and to attempt to prevent criminal violations

Section 4. SCHOOL BOARD'S CONTRIBUTION

- A. The School Board agrees to reimburse the Sheriff's Office Six Hundred Twenty-Five Thousand Two Hundred Sixty-Four and \$8/100 (\$625,264.88) Dollars for the implementation of the SRO (Safe School) Program. This amount reflects menthly costs for the implementation of the above described program at Fifty-Two Thousand One Hundred Five and 41/100 (\$52,105.41) Dollars and is for the placement of one (1) P.O.S.T. certified, fully commissioned deputy at the following specified public middle and high schools in Calcasieu Parish.
 - Sam Houston High School
 - · Mole Middle School
 - · F.K. White Middle School
 - · Oak Park Middle School
 - · S.J. Weish Middle School
 - Maplewood Middle School
 - W.W. Lewis Middle School
 - · Barbe High School
 - Bell City High School

 - Sulphur High School
 Washington Marion High School
 - LaGrange High School
 - Calcasieu Alternate Site (Career Center)
 - · Moss Bluff Middle School

The following locations will utilize one (1) deputy who will alternate between each

school location:

- Vinten High School & Vinten Middle School
- Starks High School & Starks Middle School
- DeQuincy High School & DeQuincy Middle School
 Sulphur High School 9th Grade Campus & LeBlanc Middle School
- Westlake High School & S.P. Ameri Middle School lows High School & J.I. Watson Middle School

The above stated amount also provides for the placement of one (1) additional P.O.S.T. certified, fully commissioned deputy at the following locations:

- Calcasieu Alternative Site (Career Center)
 Washington Marion High School
- LaGrange High School

The above stated amount will be billed by the Calcasieu Parish Sheriff's Office to the Calcasieu Parish School Board on a monthly basis to be distributed over a twelve (12) month time period.

The School Board further agrees to provide sufficient office space which shall include a computer with internet access for each School Resource Officer at the locations listed hereinabove in Section 4(A).

Section 5. SHERIFF'S OFFICE CONTRIBUTION

The Sheriff's Office agrees to provide P.O.S.T certified, fully commissioned deputies. The Sheriff's Office further agrees to pay the salary and benefits of the deputy, as agreed upon with School Board. This is subject to the obligation of the School Board to reimburse the Sheriff's Office as described in Section 4.

Section 6. ACCESS BY SCHOOL RESOURCE OFFICERS

It is hereby agreed between the parties hereto that the School Resource Officers assigned herein shall have access to the video monitoring system at each of the schools assigned under this agreement.

Section 7. LIMITATIONS

It is expressly understood and agreed that the School Resource Officer will at all times be under the direct supervision and control of the Sheriff's Office and the supervisors designated by the Sheriff's Office. It is further understood and agreed that the School Resource Officer shall cooperate and work with the principal at the school to which they are assigned. Although the principal is not in the chain of command at the Sheriff's Office, he or she is to be treated with respect and their requests given priority. The principal is the School Board's representative at the school. It is the intent of this Agreement that the principal and the School Resource Officer shall work together in a harmonious manner to achieve the goals outlined in this Agreement. The Sheriff's Office shall designate which deputies are to be assigned to each of the agreed locations. It is further understood and agreed that should the need arise, the deputies assigned

under this Agreement shall assist at any of the locations designated in this Agreement as determined by the Lieutenant and/or Sergeant assigned by the Sheriff's Office.

Section 8. INSURANCE

The parties shall provide to each other such insurance coverage and verification as may be agreed upon. The School Board shall be named as "additional insured" by the Sheriff's Office insurance carrier, Berkley Insurance Company, and the Sheriff's Office shall be named as "additional insured" by the School Board's insurance carrier, Berkley Insurance Company.

Section 9. INDEMNIFICATION

The Sheriff's Office agrees to indemnify, hold harmless and defend the School Board, his members, officers, agents, and employees from an alleged liability for damages to either person or property, including death of a person, arising from this agreement or caused by the negligence or fault of a Calcasieu Parish Sheriff's Office employee, agent or assign. The School Board agrees to indemnify, hold harmless and defend the Sheriff's Office, its officers, agents and employees, from any liability for damages either to person or property, including death, arising from this agreement or caused by the negligence or fault of a School Board employee, agent or assign.

Section 10. MEDIATION

For all disputes arising under this Agreement and which the parties are unable to resolve, it is agreed that before any legal action can be taken the parties must submit to mediation. The mediator shall be selected by mutual agreement of the parties. If an agreement cannot be reached on selection of the mediator, each party shall submit the name of two mediators for placement in a hat. A random drawing will then decide who will be the mediator for the dispute All costs associated with the mediation are to be paid one-half by the School Board and one-hall by the Sheriff's Office.

Section 11. NOTICE

The parties hereto agree to immediately notify one mother of all incidents and/or emergencies arising under this Agreement or the Safe School Program. The mechanism for providing this notice shall be developed by the parties so as to provide effective notice in addition to recognition of the need to not compromise ongoing or planned investigations.
